Vaccines and Morality

There are a lot of concerns and questions, not to mention politicization, around COVID-19 and its vaccines. I encourage you to educate yourself, not only on the medical aspects, but also on the moral and ethical implications. The Diocese of Manchester website has several links and resources to help wade through the ethical information (www.catholicnh.org/coronavirus).

As a pro-life people, we are called to uphold the sacred dignity of **each person**, from the first moment of fertilization until natural death. This complicates things when some companies use cell lines derived from aborted children in the design, development and production of the vaccine (Johnson & Johnson and AstraZeneca); or in the confirmatory lab tests (Moderna and Pfizer).

The bottom line is that, given the current situation, the Church says that it is morally permissible (note that it is not obligatory, not morally reprehensible) to get the COVID-19 vaccination.

However, as a pro-life people, we are also called to action – to reach out to pharmaceutical companies, strongly encouraging them to come up with ethical ways of researching, producing and testing vaccines and other pharmaceuticals.
